OFFICE ORDER

Whereas Chairman, B.R.M.T. College of Education 92, Min North, 93 Min North, 94 Min South, 95 Min South Village 154 Nanda Enclave Dhansa Road, Najafgarg, Delhi-110043 (herein referred as the institute) has preferred an application to SCERT Delhi for grant of affiliation to run two year Diploma in Elementary Education (D.El.Ed.) Course and two year Diploma in Pre School Education (DPSE) from the session 2018-2019 with an annual sanction intake of two units i.e. 100 students D.El.Ed. Course and one unit i.e. 50 students DPSE Course.

AND WHEREAS on scrutiny of the application and other documents submitted by the institute i.e. the affidavit and the recommendation received from the inspection team mentioning that the institution/Society fulfils the requirements under the provisions of NCTE and SCERT rules and relevant regulations including the Norms and Standards for the Diploma in Elementary Education and Diploma in Pre School Education such as instructional facilities, infrastructural facilities, library, accommodation, financial resources laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE Norms. The B.R.M.T. College of Education 92, Min North, 93 Min North, 94 Min South, 95 Min South Village 154 Nanda Enclave Dhansa Road, Najafgarh, Delhi-110043 is hereby granted affiliation of two units i.e. 100 students D.El.Ed. (for girls only) and one unit i.e. 50 students DPSE (for girls only). For D.El.Ed and DPSE course with SCERT, Delhi for the session 2018-2019, subject to fulfillment of the following conditions:-

- 1. Affiliation is granted initially for the academic year 2018-2019 which is extendable further subject to satisfactory performance of the institute to be assessed by SCERT.
- The institute has been accorded recognition by the NCTE vide NCTE letter no. F. NRC/NCTE/NRCAPP-201616264/Recognition/274th Meeting/2017/181336 dated 5th September 2017.
- 3. The institute will maintain suitable and adequate physical facilities in terms of space, accommodation, sanitation, laboratories, workshops, equipment, library reading room, playground etc. as specified by the NCTE, for the use of trainees of D.El.Ed. and DPSE. These facilities are liable to be physically inspected by the SCERT and affiliation will be extended subject to the SCERT being satisfied as to their adequacy and availability.
- 4. The institute will maintain number of faculty and other employees with requisite qualifications as laid down by NCTE and SCERT where applicable. It has faculty and teaching staff appointed as per recommendations of the appropriate and competent Staff Selection Committees or Departmental Promotion Committees. Salary and emoluments of faculty and staff are in accordance with those laid down for corresponding posts at SCERT, Government of National Capital Territory of Delhi.

- 5. The institute has to follow the curriculum transactions for teaching of subjects, course work, projects, school experience programme, internal assessment surveys, etc. as prescribed by SCERT for Diploma in Flementary Education and Diploma in Pre School Education.
- 6. It has adequate, verifiable, audited financial resources as prescribed by the NCTE and/or commitments from central and or State Government or self-generated resources in the form of Bank Deposits as prescribed by NCTE.
- 7. It undertakes to admit trainces who have been selected by SCERT on the basis of merit in qualifying examination i.e. 10+2 for D.El.Ed. and DPSE for the particular year.
- 8. It further undertakes not to admit any student in violation of admission process of SCERT.
- 9. It undertakes to abide by all rules, regulations, order, notification, advisories of SCERT regarding the conduct of the D.El.Ed. and DPSE Course and also the provisions as laid down in these rules. The institution shall execute a bond giving undertaking that it shall adhere the provisions of Rules and their modifications as issued from time to time.
- 10. It undertakes to charge only that prescribed amount of fees whatever SCERT notifies from time to time.
- 11. The SCERT may take into consideration for further extension of affiliation on the report of a panel appointed for inspection of the institution every year.
- 12. The institution shall pay a fee of Rs.50,000/- each course per year as affiliation fees to SCERT separately for D.El.Ed. and DPSE courses which may be revised by SCERT from time to time.
- 13. One affiliated, the institution shall comply the provision of maintaining norms of faculty and if required changes in the teaching staff due to resignation or termination. All such changes must be as per prescribed provisions of SCERT within 3 months and same must be reported to SCERT.
- 14. The institution shall furnish report viz. balance sheet, income & expenditure statement, staff statement, copy of acquaintance roll, list of students in prescribed proforoma ending 31st March of every year and required to be submitted by the end of July of every year and required to be submitted by the end of July of every year and other information to the SCERT as may be sought from time to time by SCERT.

Condition under which affiliation may be withdrawn:

- Violation of norms of NCTE of SCERT and non-adherence of any of the above conditions from sr.no. 1 to 14.
- Non compliance of any direction and affiliating rules of affiliating body (SCERT) and v) violation of any clause of NCTE Act, Regulation and notification of NCTE.
- vi) Consequent upon violation of any of the above conditions (mentioned on (i) & (ii) Director SCERT, on the recommendation of Affiliation Committee, may take appropriate action and shall pass an order accordingly.
- 15. Subject to the conditions of affiliation and other provisions related there to set forth in these rules, SCERT may lay down any other condition or conditions and the procedure which may be considered necessary to be adopted for affiliation to SCERT.
- 16. The SCERT reserves the right to inspect, seek explanations and /or information pertaining to any or all matter pertaining to the above. During this period, if any violation is noticed or quality is not up to the mark, SCERT will be at liberty to withdraw the affiliation.
- 17. The SCERT, reserves the right to reduce the number of trainees and /or withdraw affiliation for the D.El.Ed. course for specified period, if the manpower planning for teacher in the GNCT of Delhi so demand.
